



COVID-19 PRECAUTIONS

The staff at Leisure Chateau is comprised of dedicated caregivers and medical professionals committed to our residents' ongoing health. As always, our priority is keeping both our residents and employees safe. During these difficult times this has meant implementing new protocols and precautionary measures.

- **DAILY SCREENING** To ensure that everyone remains healthy all employees, nurses, residents, and healthcare professionals are screened for possible COVID-19 symptoms before entering the premises and all of our residents are screened twice daily
- **DEDICATED COVID-19 UNITS** In addition, to help mitigate the spread of COVID-19, we have designated a COVID-19 unit for residents who may have contracted the virus.
- **PERSONAL PROTECTIVE EQUIPMENT (PPE)** To further protect our residents, we provide our staff with an adequate supply of PPE to be worn at all times which includes gloves, gowns, and N95 masks.
- **HAND-WASHING SUPPLIES** To keep our beautiful building and each resident's room completely safe, our housekeeping staff is ensuring that there is an adequate supply of alcohol-based hand sanitizer for every resident's room, as well as all common areas such as hallways, nursing stations, and the main lobby. In addition, our contracted housekeeping service frequently cleans and disinfects all high-traffic areas with an EPA-registered disinfectant.
- **VISITOR PROTOCOL** Leisure Chateau is a place where visitors have always been welcome. Therefore, even during these difficult times, we have created a beautiful outdoor visiting space, where residents can enjoy visits from friends and family safely. Visitors are restricted to two visitors per time and no children are allowed to visit at this time. Visitors are required to maintain 6 ft. social distancing and wear masks during their visits. Any new resident must quarantine for 2 weeks before receiving any visitors. However, during this 2 week period, a designated area has been assigned to facilitate safe and secure at window visits for those residents.
- **LIMITED NON-ESSENTIAL HEALTHCARE WORKERS** No visitors are allowed inside the facility at this time except for specific circumstances of compassionate care, such as end-of-life situations. All allowed visitors are screened for COVID-19 before entering and must wear a face covering, gown, and gloves while in the facility. They must also restrict their visit to the resident's room or another location designated by the facility. We have also cancelled all non-essential healthcare appointments, both on-site and off-site, until further notice.

Unfortunately, COVID-19 is still evolving and as the situation changes, so do our protocols. In order to ensure that we are always up-to-date, we provide ongoing education for our entire staff. This includes briefings on early detection, demos on hand-washing and proper mask usage, and distributing & posting a COVID -19 fact sheet with any crucial information as soon as it develops.

We will continue to keep an open line of communication with our residents' families to keep you updated on the latest changes in our COVID-19 response.
